## **Allenton, Colman Township**

**Blinsmon (Blinsmon Township)** – Post Office established August 4, 1875 – closed December 6, 1893

**Brain (Ward Township)** – Post Office established October 12, 1887 – closed November 16, 1887. This was an attempt to change name of Groveland

**Brookfield (Blinsmon Township)** – established August 19, 1873 –changed to Trent on July 21, 1887

**Clifton (Union Township)**– Post Office established July 8, 1878 – closed March 13, 1878

**Colman (Colman Township)** – Post Office established September 8, 1881

**Dyce (Jefferson Township)** - Post Office established January 13, 1898 – closed September 30, 1902

**Egan (Grovena/Egan Township)** - Post Office established June 22, 1880 – closed January 2, 2006

**Enterprise (Enterprise Township)** - Post Office established August 7, 1879 – closed March 10, 1881

**Flandrau (Flandreau Township)** - Post Office established August 28, 1883 – closed March 22, 1886

**Flandreau (Flandreau Township)** - Post Office established July 17, 1874 – closed August 28, 1883 – Reestablished March 22, 1886

**Frankfort (Ward Township)** - Post Office established July 12, 1878 – closed September 12, 1882 - Name changed to Groveland

**Gale (Egan Township)** -Post Office established May 20, 1879 – closed October 3, 1881

**Galla (Fremont Township)** - Post Office established December 26, 1882 – closed July 14, 1900

**Gibbsville (Flandreau Township)** - Attempted to make Flandreu PO

**Glen Roy** - Post Office established March 27, 1879 – closed November 13, 1879

**Groveland (Ward Township)** - Post Office established September 12, 1882 – closed August 30, 1887

**Hillsdale (Egan Township)** - Post Office established December 23, 1874 – closed May 16, 1877 – Reestablished March 4, 1878 – closed March 3, 1884

**Keith (Union Township)** - Post Office established May 26, 1884 – closed February 28, 1887

**Kila (Blinsmon Township)** - Post Office established September 13, 1889 – closed June 11, 1891 – Reestablished May 21, 1894 – closed February 27, 1895 –

**Lone Tree (Egan Township)** - Post Office established December 1, 1879 – closed September 9, 1880

**Manley (Riverview Township)** - Post Office established August 6, 1894 – closed January 1901

**Marshall (Blinsmon Township)** - Post Office established January 13, 1874 – closed April 20, 1880

**McCurdy (Fremont Township)** - Post Office established June 30, 1892 – closed October 15, 1902

**Midway (Fremont Township)** - Post Office established July 5, 1881 – closed January 13, 1882 – Reestablished February 15, 1882-October 19, 1891

**Orior (Riverview Township)** - Post Office established September 27, 1881 – closed August 21, 1884

**Ralph (Riverview Township)** - Post Office established October 17, 1878 – closed December 8, 1881

**Redwing (Flandreau Township)** - Post Office established December 23, 1874 – closed December 17, 1875

**Roscoe (Flandreau Township)** - Post Office established April 10, 1878 – closed June 3, 1878 – Reestablished July 2, 1878-June 23, 1880

**Sankey (Colman Township)** - Post Office established March 31, 1880 – closed September 8, 1881 – Name changed to Colman

**Sealsville (Fremont Township)** - Post Office established June 18, 1874 – closed October 19, 1874

**Sioux Falls Junction (Egan Township)** – Locale where east-west railroad tracks joined north-south tracks

**Smyth (Clare Township)** - Post Office established February 14, 1889 – closed November 30, 1899

**Trent (Blinsmon/Enterprise Township)** - Post Office established July 21, 1887

**Ward (Ward Township)** - Post Office established January 10, 1890

**West Bend (Flandreau Township)** - Post Office established January 31, 1873 – closed July 11, 1873
